STATE OF NEW HAMPSHIRE COMMISSION ON LAW ENFORCEMENT ACCOUNTABILITY, COMMUNITY, AND TRANSPARENCY

The New Hampshire Commission on Law Enforcement Accountability, Community, and Transparency will hold a meeting on: **August 10, 2020 from 9:30 a.m. – 1:30 p.m. This will be a video conference meeting.**

The Commission invites all interested public, private and community stakeholders and members of the public to present testimony regarding the current state of relationships between law enforcement and the communities they serve, and potential steps that can be taken to enhance these relationships.

The Commission requests that members of the public wishing to present testimony email the Commission in advance of the hearing at: LEACT@doj.nh.gov. The Commission strongly encourages the submission of written testimony in advance of the hearing at the same email address. *Please note: all emails sent to this address, including attached documents or other media, are considered public and will be included on the website, as part of the written testimony considered by the Commission.*

Presenters will be limited to 3 minutes of testimony to summarize their written submission. Commission members will then be given an opportunity to each ask four questions. Time limitations may be increased at the discretion of the Chair.

Pursuant to the State of Emergency declared by the Governor as a result of the COVID-19 pandemic, the requirement that a quorum of a public body be physically present is waived. Therefore, in accordance with Emergency Order #12, Section 3, Commission members will be participating in the meeting remotely via video conference. Members of the public may attend this video conference by using the access information below.
