Discussion of idea for upcoming year:

- Suggested topics for projects or ideas with the goal of having 2-3 to suggest to the Governor's office to see what he responds to best
- Easier ideas to develop:
 - Tool-kit and guide for hate crime, hate incident, discrimination (could be handled by Civil Rights Unit)
 - Improving training and standardizing training across state agencies (follow up on previous conversations with Bureau of Education and Training)
 - Giving visibility to the importance of doing this and the question of what is the State's commitment and what the responsibility is.
 - What is happening or has been done? How even or uneven the training is?
 - Ensuring a degree of consistency across the State
 - Training as a commodity v. a service to be provided without cost
 - Training as a tool to reduce risk and liability as well
 - Centralization of certain personnel services
 - Data on training from BET; how much is wasted or lost by not running full classes
 - Employee retention question
 - Do you need our help to support training initiatives across the State?
- Increasing substance use and psychiatric services access: this is something undertaken by DHHS at this time; not sure how much to add when this is a priority for the Department
- Communication access there is a Civil Rights nexus and what are agencies doing at this time
 - Is it more than just a sign allowing a person to request communication access; is it meaningful?
 - A state-wide contract versus having each agency setting up an arrangement with a language access partner, also access for deaf and hard of hearing who may not be fluent in ASL
 - DOT's language access plan is very comprehensive
 - 911 could be a good example too
 - Consistent policies and ensuring consistent access
 - Idea of developing a model policy and training recommendation to send to the Governor's Office
 - Translating websites into other languages and forms: starting with even just one language and phone access
 - o Ensuring that language access is broadcast to the public to know about it
 - Social media/website policies with alt text for screen readers

- School DEI initiatives and talking with those doing the work and what school districts are doing between hiring directors or having a committee-based model.
- Next Steps:
 - Outreach to DEI coordinators for school districts to see if they could come to a meeting the next several months (Sean Connor to come up with a plan/timeline for outreach – Concord, Manchester, Exeter, Timberlane)
 - Outreach to BET for training staff to come in (Jeremy)
 - o Gathering model policies and plans on language access (DOT/DHHS/911 other agencies)

 - o Fundraising and portrait will be the next steps
