Subject: LEACT - Suggested Governing Principles

The following is being sent on behalf of the Chairman, Attorney General Gordon MacDonald, and his designee, Deputy Attorney General Jane Young.

In an effort to be as efficient as possible during our 3-hour meeting tomorrow, we have compiled (as best we could) the Commission members' recommendations into topics. That compilation is attached. When deliberating on the recommendations, please keep in mind the following guiding principles:

1. The Commission should strive to speak with one voice.
2. To do so, will require working to achieve consensus, and inevitably, compromise.
3. Final recommendations should be clear and concise, as our ultimate audience is, in addition to the Governor and other elected officials, the people of New Hampshire.
4. To the extent a recommendation will require additional spending and there is an estimate available, we should include that estimate. However, Commission members should understand that, for state-related spending, the current budget is in effect through July 1, 2021. Thus, items requiring a major new appropriation or

reallocation of resources will likely have to be addressed in the next budget. Our work is timely, though, because the budget planning process will begin in earnest next week.

Thank you for your attention to the attached compilation, and we are looking forward to a productive discussion in the morning.
