Healthcare System Relief Fund Awardee Overview

The Governor authorized the allocation and expenditure of a total of \$100 million in emergency funding from the CARES Act Coronavirus Relief Fund (CRF) to support Healthcare providers with COVID-19 related expenses and lost revenues from March 1, 2020 to December 30, 2020. On June 11 and June 12 the COVID-19 Emergency Healthcare System Relief Fund (CEHSRF) Supplemental Application and the Long Term Care Provider Program two programs of the Healthcare System Relief Fund opened for applications. The applications for both programs closed on June 19 at 11:59 PM. Below is a preliminary list of awardees, with a potential for additional grants being awarded following the conclusion of an additional review process.
