EXPLANATION

Seasonal Biological Aides are needed to conduct marine recreational fishing surveys and supporting seasonal field work for federal projects that F&G Marine Division is obligated to conduct.

1. What services or constituency group will be affected if this position is not filled?

This position is needed to maintain project deadlines that increase on a seasonal basis. Federal aid projects and associated MOA work will not be fulfilled without this seasonal position. Without data collection efforts during seasonal periods this will affect stock assessments, fishery management decisions, and ultimately affecting the recreational and commercial fisheries in NH.

2. Are the services/duties performed by this position required by law, rule, court order or some other mandate? If yes, explain.

This position is needed to fulfil MOA's and federal/state funded obligated projects.

3. Did the position become vacant because of a promotion or personnel action within the organization, or did the incumbent move to another state position? Define

The position is seasonally based. The project field work increases exponentially from spring through late fall that requires parttime help to achieve obligations of state/federal projects.

4. Can other personnel within the department cover the duties of this position? Explain in detail

The Division is a small division and efficiently staffed, therefore other staff have full time field work and project related responsibilities and need supporting seasonal staff to assure of project obligations.

5. Can the duties be completed by a part-time position? Explain in detail

The requested waiver is for a seasonal position.

6. If this position has been vacant for a period of time, explain how the work previously done by this position has been allocated to, or covered by others during this vacancy period.

This position addresses seasonal work that is obligated and needs to be conducted as soon as possible based on project timelines.
