RE: Submission of Testimony to Commission on Law Enforcement Accountability, Community, and Transparency, Established by Executive Order 2020-11 on June 16, 2020 – Public Document

Attention Chairman Attorney General Gordon MacDonald, and Mr. Ken Norton, Executive Director, National Alliance on Mental Illness – New Hampshire

Dear Commissioners:

It was published in The Granite State News Collaborative that Governor Sununu established the Commission because he wants a reexamination of everything from police training to misconduct investigation, and that time is of the essence for recommendations to be delivered in 45 days. The website solicited testimony to be sent to the cited email address.

Considering that NH Attorney General MacDonald already has a substantial file on my complaints about misconduct of the New Hampshire Criminal Justice System with special attention to:

- my illegal arrests (all four of them),
- the illegal seizure of all my evidence of complaints of Racketeering and Public Corruption to steal all my family property in NH to include its most valuable assets attached to the High Birches Springs property located in North Woodstock, NH with a reservoir estimated of 10 million gallons per days, attached permits to extract up to one million gallons daily and worth multi-millions of dollars, and compensatory business damages, plus pain and suffering (trebled).
- The illegal booking using my Panamanian identity Jean Elizabeth Allan Sovik, in case 09-cr-1293,
- the abuse I suffered in jail while awaiting my arraignment,
- the illegal appointment of a conflicted Public Defender,
- the false testimony incorporated into the October 13, 2009 Office of Forensic Evaluation Report which found me Delusional to testify and present an affirmative defense at my trial (see file of October 13, 2009 Report in Office of AG MacDonald, or nhjustice.net in the High Birches Spring section titled No Witness = No Case, or posted on my FB page Jeanie Allan)
- the two Laconia District Court Judges Orders based solely on the October 13, 2009 Diagnosis without an evidentiary hearing, and in violation of NH Statutes and Constitution, which ruled that I was Not Competent to be tried.
- NH legal position that it had sole power and jurisdiction pursuant to Full Faith and Credit Act to reevaluate my competency.
- The case was dismissed without prejudice, and legally should and can be tried in court.

I need not elaborate here. As AG MacDonald can confirm, I have repeatedly requested that NH grant me safe passage back into the State so I can file a Writ of Coram Nobis on the

global complaint issues, which include, but are not limited to multiple frauds upon the NH State Courts, but also on the NH US District Court in Concord, NH.

While awaiting NH response, I have also been given a case file number on my global RICO and Public Corruption Complaints by the US DOJ Criminal Division, Fraud Section #ER300900086. Recently, I was encouraged that FBI apprehended Ghislaine Maxwell merely 65 miles south of High Birches Springs location. Very fitting. I pray that she does cooperate with FBI, and the rest of the information that has been hidden for so long is finally known to the public.

If the Commissioners take the time to read the Historical Background section (about 10 pages) in the October 13, 2009 Diagnosis, they will find that my legal situation began when I caused the whistle to be blown on the Blondheim Ponzi Scheme back in 1983, and then the retaliation against me began when my name was leaked. Interestingly, as part of the retaliation scheme to entrap, and ruin, me is where Jeffery Epstein and his confidant Ghislaine Maxwell fit in; but, this has all been hidden from the public due to the special treatment they, and their elite cronies have received from law enforcement, both State and Federal. We are now just learning about their ability to corrupt public officials with blackmail. And, I suspect, if Ghislaine does begin to share her evidence with FBI and Barr's US DOJ, I will have the rest of the proof I need to show the courts how I was railroaded by NH Law Enforcement.

After all these years, my family prays that NH finally will enforce accountability and transparency upon all those corrupted Officials who have caused such damages to my family, and to the tax payers of the State of New Hampshire. # Live Free or Die Trying.
