The New Hampshire Commission on Law Enforcement Accountability, Community, and Transparency will hold a meeting on: **July 14, 2020 from 9:30 a.m. – 12:00 p.m. This will be a video conference meeting.**

The Commission invites all interested public, private and community stakeholders and members of the public to present testimony regarding police training curriculum, procedures and policies with a specific focus on de-escalation, use of deadly and non-deadly force and diversity training.
