

**Commission on Law Enforcement Accountability, Community and Transparency**

**Meeting Minutes for July 31, 2020**

Meeting held via videoconference at the Attorney General's Office in Concord, NH.

**James McKim**

Has concerns about the specific charge as it is written and would like clarification.

**Judge Gardner**

Grammar note, on page 5, the sentence should read "or procedures" not "are procedures."

**Attorney Julian Jefferson**

On page 9, under policies to be created (recommendation #8),

**Joseph Lascaze**

On page 3, under the first paragraph, need to add and clarify that there is no finding that people of color are over-represented in the virtual training scenarios, but it is clear that people of color are used in the scenarios. (Commission members had several discussions about the addition of this sentence and how to grammatically word it to be inclusive of all minority groups.)

Lt. Morrison recommended the following wording of the sentence addition. Eddie Edwards moved to accept the addition, Director Scippa seconded the motion. A roll call vote was taken on the motion and the votes were recorded as follows:
