## Review and Approval of August 25, 2022, Meeting Minutes

- Mary Krueger: Our minutes are the only official record of the Commission meetings

# Review and Update of the Supreme Court Task Force Discussion on Domestic Violence Cases in the New Hampshire Judicial Branch, presenter New Hampshire Supreme Court Justice Hantz Marconi.

- Judge Hantz Marconi:
  - After an incident occurred last fall, an internal investigation recommended a task force which Judge Hantz Marconi led.
  - O The task force was started December 1, 2021 and produced a report March 1, 2022. The task force included various stakeholders. Formed working group. Met 2-3 times/week. Organized around 6 specific charges. Goal was to identify issues and make recommendations.
  - The Commission on Domestic Violence, Sexual Assault and Stalking stopped meeting mid-teens and resulted in communication gaps.
  - o First charge review of current court practices
    - recommendations-many branch specific
    - improving public experience
    - harmonizing paperwork process
    - effective orders of protection
  - o **Second charge**: review current status of the law
    - for example protective order for sexual assault doesn't exist but would require legislative action
    - simultaneous criminal and civil cases

- caseloads challenging- circuit court 25,000 hearings/year. 15 a day/judge
- identify other resources like the battered women's justice project.
- o Third charge: gap in publication of non-precedential orders
  - VAWA prohibits online posting without scrubbing them so gap 5-6 years not online. Could still access on paper, email but not on internet. Non-precedential but still helpful guidance.
  - Sen. Carson asked, "what is non-precedential?"
  - Judge Hantz Marconi replied that non-precedential does not constitute or set a precedent, not in case law. Court releases orders that are rule law.
  - Have to also balance with right to know
  - Have to look at what is identifying info
- o Fourth Charge: review of current court forms
  - Make sure responsive to litigants
  - Make more user friendly and accessible
  - Judges need complete petitions to make informed decisions. For example, flow charts that describe process can't be legal advice but something stakeholders can share.
- Fifth Charge: explore available legal and advocate assistance for survivors
  - History of existing programs
  - There is a gap in support for modest income earners
  - Don't have legal representation or advocates for sufficient number of litigants. See pie chart.
    - o 95% self represented stalking orders
    - o 87% self represented domestic violence protective orders
  - Recommendations: More education, funding, better communication between courts and crisis centers
- Sixth Charge: review current state of relationships
  - Formed Governor's Commission 1993, review of timeline
    - Recommend reestablishing Commission

- Seventh Charge: other
  - Transparency & Accountability=better data
  - Firearms relinquishment
  - Wire-tapping and eavesdropping may be low hanging fruit for the legislature
  - Court Approved batterers intervention: no uniform standards

- Separated out what Judicial Branch can do and what this group can do
- Two biggest recommendations: Standing committee DV in Judicial Branch & reconvene this commission

  - Best practices-refer to crisis centers

- Legal Aid should explore enlisting more volunteer attorneys to help survivors draft legal documentation
  - Senator Carson: passed legislation re: paralegals who would be able to assist with this
  - o Judge Hantz-Marconi: that will be really helpful
- General discussion regarding Charge Five recommendations
  - Judge Hantz-Marconi: Access to Justice navigator program available to all
  - Mary Krueger: Manchester circuit court starting in October providing assistance targeted to DV
  - Diane Martin: working to identify resources for 603 onsite & remote
  - Angelika Wilkerson: focused on drafting stage of petitions.
    Granted temporary but not always complete. So if can't have attorney at final hearing, will have better record.
  - Mary Krueger: Family Justice Center Pilot previously in Manchester assisted with drafting. We know it works, but need resources to do it.
  - Judge Hantz-Marconi: also helpful to defendant so they can properly defend. Helps process.
  - Senator Carson: Information is very siloed. I wish I had known that resource is available. Develop a way for better communication to serve both plaintiffs & defendants.
  - Diane Martin: Judicial Branch referred suggestion about remote representation
  - o Judge Hantz-Marconi: particularly in north country
  - Angelika Wilkerson Wilkerson: from pro-bono perspective during covid remote hearings could represent someone anywhere in state. Excited to see what Alliance for Justice recommends.
  - Diane Martin: increase pro-bono and resources for appeal, collaborating with the bar on CLE to provide more I information to attorneys to encourage taking cases
