 - Sean L. can look into this

Subcommittee Updates:

- Outreach and Education:
 - o What do we want to do? What is the scope of the Council? Recommend? Facilitate?
 - Idea is to bring ideas to the Council to pursue
 - Example of trainings on disability-related issues
 - O How do we know what is going on out in the world?
 - Listening sessions
 - Casting a wide net by developing a survey and partnering with groups that we have yet to identify to push out the survey, could bring in students and other stakeholder groups to help inform the survey and make sure we are serving the correct populations—what do people need
 - Example of young people staying in the state:
 - Does some of this data exist elsewhere that we could access and use for analysis?
 - Figuring out how to leverage individual council members activities and engage through those efforts—i.e. a Council member participating in a particular activity could do so and engage with those groups as a Council
 - How do we prioritize where to start and what we do across different sectors and across the State?

 research on issues of discrimination and supporting diverse
 communities.

- A component or idea is to start small and identify a group or area to work with and do
 the outreach and see what the needs are (i.e. new immigrants to the United States and
 what resources the groups that assist them provide and the reality of accessing those
 services).
- o DEI Recruitment and Retention in businesses, state agencies, schools, etc.
 - Leveraging our partners in the CCSNH and USNH to develop surveys and how to approach these situations. How can we improve across the state our DEI Recruitment and Retention efforts—i.e. MBA students or other students groups that could help develop the surveys and synthesize the data to make recommendations.

Government Relations

- o Met and discussed doing a legislation tracker for those going through the legislature
- o Created a spreadsheet to keep track of bills of interest and where they are going
- Share the list of the bills being monitored and the status to facilitate the planning
- If it is going to go all the way through what would we recommend to the Governor looking more closely after cross-over
- Other aspects of State government—trainings on diversity and inclusion and getting a sense of what different agencies and departments doing to make recommendations on best practices
- May need to revisit the standing meeting time
