  - Data collection is being done at the Continuum of Care level (Balance, Manchester, and Nashua) and then all being uploaded into on space
  - Housing stability people are not experiencing homelessness, couch surfing, double up,
     etc. People are living in a stable home and able to pay their housing costs.
  - o Will look into the additional data points the Continuums of Care will gather.
  - Helpful to have opportunities to shine a light on the work that overlaps, Ann and Commissioner Quinn could keep the GACDI updated on those efforts.
- Thoughts training for onboarding in all executive branch agencies regarding diversity and inclusion to make the State more accessible to the public
  - o Discussion of BET's DEI training and incorporating into onboarding
  - A recommendation could be made about DEI training within the state or for state agencies to collaborate on being more accessible or avoiding discrimination
