Welcoming New Member:

• Dina Chaitowitz member of the Jewish Federation of NH and previous federal prosecutor and started a civics program (Civics 603) in NH. Became involved in advocacy for legislation on Holocaust and genocide education.

Honoring Rogers Johnson:

- There had been some outreach about the memorial and the bench on the Black Heritage Trail
- The issue was the cost and the transition among members of the Council.
- Granite bench which would cost approximately \$1400, but we could do something different but the idea of something that would be part of the Black Heritage Trail.
- Payment would require some degree of fundraising because the Council's budget could not pay for this.
- Possible that prior members may be willing to contribute.
- Donate the roll over funds to the Black Heritage Trail, possibly?
- Possibility of involving the Seacoast NAACP
- Simplest thing to make the contributions to the Trail and then roll any excess funds into the Trail's operation and maintenance
- Allowing people to participate would not take anything away
- General consensus of amenability to the bench on the Trail with excess going to maintenance.
- Commissioner Quinn will discuss with the Trail the bench and location.

Education Tool-Kit:

- Everyone received the rough draft
- The Attorney General's Office is going to look through the assembled draft to make sure we are not creating legal quagmires potentially and return any notes to the Council.
- The idea is not to add new content, but refine content instead, until the AG's Office has looked at it.
- Then we can have a deeper conversation in September about the document
- The Governor's Office will also want to weigh in on this before we finalize it.
- Questions about the existing document and some suggestions of revisions
- Discussion about other potential groups to tap to look at the tool-kit
